They did a study in Southern Chester County to show where there was internet connectivity as well as where there are connectivity issues with a grant received from Department of Industry. They are now interested in doing this for the rest of the County now that the funds are available.

Jessica states that there is a possibility that they may not get awarded any funds.

The Broadband Development Authority will be in charge of distributing the money, so local governments can partner up with ISP's for the grants.

The overall presentation of Whitney, Jim and Jessica was to get try to get local municipalities to help with the ISP's to understand what connectivity issues they are experiencing, where they are, who needs last mile connection and who's underserved.

In conclusion, the WCCCOG does not find it feasible for the municipalities to help collect information for this project. It was suggested that a phone number be given to the residents to be able to contact the Alliance themselves.
